# Who is the Data Controller?

# What is the purpose of processing the data?

The Accommodation Service will process the information given by applicants/students for the purposes of accommodation offer and booking processes, the management of hall facilities and management of issues related to the terms and conditions of the Accommodation Licence Agreement for students who become residents including behavioural issues and the pursuit of accommodation fees.

Applicant/student details may be shared by the Accommodation Service with University of Greenwich staff and third parties that the university engages for the aforementioned purposes including hall management providers, administrators of the accommodation database, hall insurance providers and agencies contracted for the pursuit of hall fee debt.

Data provided relating to disability and/or health-related matters may be shared with University of Greenwich staff if necessary. This information may also be shared with outsourced hall staff if necessary in order to assist with hall and room allocation and/or to ensure the health, safety and security of the student/applicant and others. If applicants/students do not wish for this information to be shared with outsourced hall staff they are advised to contact the Accommodation Service in writing but they should note that this may affect the ability of the Accommodation Service to provide them with the most suitable hall and room allocation.

Name, hall addresses, university email addresses and nationality of resident students may be passed to the Electoral Services to allow them to alert students to voter registration. If applicants/students wish to opt out of this they are advised to contact the Accommodation Service in writing.

# What are the categories of data being processed?

- Title
- Name
- Date of Birth
- Gender
- Permanent Address
- Email addresses
- Telephone numbers
- Emergency contact details

- University ID
- Programme of study
- Financial information with regard to accommodation-related fees and charges
- Information provided by applicants/students regarding their accommodation needs, hall/room preferences, etc. including disability or health-related information.

#### What is the legal basis for processing the data?

A contract with the individual is the primary condition for the processing of this data. Accommodation Services may also rely on vital interests as a reason for processing data with regard to the health, safety and security including the need to contact the applicant/student's listed emergency contact person.

## Who will the data be shared with?

- University of Greenwich staff if necessary
- Third parties that the university engages for accommodation-related matters including hall management providers, administrators of the accommodation database, hall insurance providers and agencies contracted for the pursuit of hall fee debt, if necessary
- Electoral Services

## Will data be shared overseas, and, if so, where and how?

Data will only be shared overseas on a need to know basis with agencies involved in hall fee debt pursuit if referred by the university's UK agency.

## What will be the retention period of the data, or the criteria to determine it?

Data will be kept for 6 years plus the current academic session year.

## Will the data be subject to automated decision making?

There is no automated decision-making.
